MASTER OF SCIENCE IN HEALTHCARE ADMINISTRATION (M.S.)

Purpose

The Master of Science in Healthcare Administration program prepares students who are pursuing management careers in any of the various healthcare organizations or supporting health entities. The program is designed for students to be effective, ethical managers and administrators in the field. Students will learn how to be successful in the healthcare organization, manage operations and personnel, ensure quality, and maintain compliance with laws that affect healthcare providers, administrators, and organizations. Coursework will encourage intense research, review of best practices, and application of new knowledge to challenge student learning focused on organizational value creation, planning strategically, employing high-performance business management techniques, and utilizing financial models and principles to make evidence-based decisions within the context of the modern healthcare environment.

Program Learning Outcomes

The student will be able to:

- Provide solutions that align with a biblical worldview to problems associated with cost, access, and quality of care.
- Evaluate environmental factors impacting the management of healthcare organizations.
- Design strategic planning initiatives that incorporate financial analysis, human capital management, operational improvement, marketing, and legal/regulatory compliance based upon knowledge of current literature and industry best practices.

Program Specific Admissions Requirements

In addition to the general admission requirements, admission to candidacy in the *M.S. in Healthcare Administration* program requires:

- Earned baccalaureate degree or its equivalent from an institution accredited by an agency recognized by the U.S. Department of Education (e.g., SACSCOC, TRACS, ABHE, etc.)
- 2. An undergraduate cumulative GPA of 3.00 or above (on a 4.00 scale)
- 3. TOEFL (if applicable)

Students who do not meet the minimum GPA requirement may be admitted on Academic Caution status. Students who have less than an undergraduate 2.5 GPA will not be admitted to the program.
